CONTENT CONTEST RULES

WHEN

The Contest consists of four stages.

Stage 1. August 6th to August 23rd, 2021. Entry submissions are accepted. Early or late entries are illegible. Time is determined by the upload time.

Stage 2. August 24th to August 29th, 2021. Likes are gathered. We will make a shortlist of the 20 most liked entries.

Stage 3. August 30th to September 3rd, 2021. A jury comprised of the Waydoo management team members and global partners will vote for their favorites.

Stage 4. September 4th, 2021. Winner announcement.

PRIZES

1 Grand Prize = A Waydoo Flyer ONE EPP electric hydrofoil board, or US\$5,299 Waydoo in-store credit, and a chance to become a Waydoo Brand Ambassador.

HOW TO ENTER

- For photo entries

- For video entries

Step 1. Record a video yourself, your family or friends riding and having fun on the Waydoo Flyer ONE. The video needs to be no more than 3 minutes long and have a close-up shot of the Waydoo logo.

Step 2. Upload the video to Youtube with a minimum 1080P definition.
